Discussion Item #1: Solar Presentation by Oregon Interfaith Solar Project

Presentation led by Lou Stagnito

The Governing Board received a presentation describing installation and use of solar panels for supplying electric power to the property. Details included a 20 year lease of the panels/equipment; at the end of the lease the equipment will belong to NFUMC. NFUMC can expect the panels to last approximately 30 years. If NFUMC is interested in this possibility, Collective Sun will prepare a proposal for installation (which may include several scenarios for installation) based on recommendations from contractors and providers. In order to receive a proposal, NFUMC will complete an application, to include

NFUMC statistical report; Annual Report from Trustees; Fund Balance Report provided to the OR ID Conference and an essay to include responses to the following:

- 1. What is NFUMC doing in ministry?
- 2. Who are partners in ministry with NFUMC?
- 3. What does future ministry look like for NFUMC?
- 4. How does NFUMC fund its ministry?

Timelines:

For analysis and giving NFUMC a proposal for installation: 30-60 days after completed application is received.

For completion of installation project: 12 months

Following discussion, the Board agreed by consensus to submit an application to Oregon Interfaith Solar Project, in order to receive proposals for installation.

Discussion Item #2: Building Use Forms

Pastor Casev

After discussion, by concensus agreement, the Board decided to estimate room/building capacities and use the forms as written. The Board will revisit these forms in a year based on user/member feedback. GB granted pastor discretionary ability to waive/change fees.

Discussion Item #3: Dundee Update

Dave Paul

The workgroup met with representatives of By His Grace Fellowship, who reported various problem areas, including half roof to be replaced in 1-3 years. The work group affirms the problems should be addressed sooner rather than later, and BHGF agrees to partner with NFUMC; based on a variety of repair needs, some of these would be hired out. The workgroup is considering: child/day care option for first floor space (of new construction) including Head Start; other community services who could be tenants; review of site plans; looking at playground options which would be required if a child/day care center uses the first floor space.

Discussion Item #4: Camp Scholarships from Endowment Dave Paul The Endowment workgroup met 5/10/23 and designated a total of \$2000 for camp scholarships. It was moved by Brenda L. and seconded by Kathy D. to approve the following disbursement of funds, designated by the workgroup: \$263 (Camp & Retreat Ministries fund), \$449 (Dorothy Noyes fund), and \$1288 (Family Ministry fund) = \$2000. In addition, the Men's Group is providing \$100 per camper (20 NFUMC campers) = \$2000.
